Dear Law School Deans, Admissions Directors, and Representatives:

We look forward to welcoming you to our annual Portland Law School Fair. Please note that we were required to move the fair from Saturday until Monday because our university closes for Veterans' Day.

WHEN AND WHERE

The fair will be held on MONDAY, November 13, 2017, from 11:00 a.m. to 2:00 p.m., in the Smith Memorial Center Ballroom on the Portland State University campus in downtown Portland.

We advertise the event with student organizations throughout Oregon and southern Washington, and you can expect to meet students from Portland State University, Oregon State University, Reed College, the University of Portland, Western Oregon University, Lewis and Clark College, Willamette University, George Fox University, Pacific University, Washington State University-Vancouver, and many other institutions throughout the Pacific Northwest.

ARRIVAL

Transportation from Portland International Airport (PDX): PDX is located 9 miles east of downtown and is served by most domestic airlines. One way to get in from the airport to a downtown hotel is by the Tri-Met Max light rail service, which takes about forty-five minutes to an hour. For schedules and information, check www.trimet.org. The airport station is located right outside of the terminal. Taxis are easily accessible at the airport, and some local hotels offer their own shuttle service. The major rental car agencies have offices at the airport.

Locating the PSU Campus

You can locate a PSU campus map at: www.pdx.edu/campus-map. You will find that PSU may be accessible by streetcar or light rail, depending on the location of your hotel. For information on those sources of transport, see www.trimet.org.

Parking is always at a premium around the PSU campus, and it will be particularly difficult to find a spot after around 9 a.m. Be sure to arrive a little early if you drive so that you do have time to find a spot. Unfortunately, I am not allowed to provide you with special parking privileges, AND I CANNOT PAY FOR YOUR PARKING TICKETS. urban university jammed into a compact area. If you must drive, be sure to allow time for parking.
