## Parking:

**Parking is very limited at Arizona State University**. We have reserved parking for representatives at ASU Law School Fair. Parking will be in the **Apache Boulevard & Rural Road Parking Structures**. We will validate your parking at the fair; please bring your parking ticket with you to the Fair. We also recommend that you arrive early to avoid traffic entering the structure.

**Apache Boulevard Structure**: Entrance is located just north of the Normal Avenue and Apache Boulevard intersection. If you are using a GPS or Google, the nearest address for the parking structure is 300 E Orange St, Tempe, AZ

**Rural Road Structure**: Entrance is located off the traffic light at the intersection of Rural Road & Terrace Road.

There is also a light rail stop located within walking distance of the Memorial Union. Please visit <u>http://www.valleymetro.org/metro\_light\_rail/</u> for more information regarding the light rail system.

• From Sky Harbor Airport:

Take Loop 202 East to Scottsdale/Rural Rd. (Exit 7) Turn right (south) onto Rural Road and proceed to Apache Boulevard Turn right (west) onto Apache Turn right (north) onto Normal Avenue Turn left (west) onto Lemon Street; the entrance to the Parking Structure will be on your left
